



## **Proceso de Obtención de Subvenciones de Aid Live**

Aid Live is focused on promoting the integration, comprehensive development, and wellbeing of the Venezuelan children in vulnerable communities in Venezuela and Venezuelan refugees in Colombia.

We believe in the importance of the mid and long term program, going beyond traditional programs that address the humanitarian emergency to provide well-being and improve the health and nutrition, especially in children and young people.

This translates into a powerful exchange of ideas and a community of opinion leaders who provide local solutions.

### **1. Collaborative Project Development**

Aid Live works with partners on a select number of issues. Given this strategic focus, we do not accept unsolicited proposals at this time.

Our technical team reviews the proposals of our partners to guarantee that they are aligned with our vision.

### **2. Proposal Invitation and Submission**

Once we identify the partners, we start a due diligence process. Only the non-profits organizations who fulfill all the conditions requirement will be called to send the final proposal submission.

### **3. Funding technical review**

The Aid Live technical team will evaluate the final proposals and favors proposals that demonstrate:

- A clear plan with cost-effective strategies, objectives, and outcomes.
- A well-defined evaluation plan, collaborations or active partnerships.
- An approach to address gaps in current services and interventions.
- Involvement of a diverse set of advisors and stakeholders.
- Mid-term commitments to help transformation take shape over time.

- Partnering with multiple players from grassroots organizations to grassroots leaders to create systems change.

If the technical staff of Aid Live foundation has any consultation about the projects could submit the proposals to the Advisory Board to get their feedback and share it with the Executive Board.

#### **4. Funding decision**

The final decision to approve the proposals and grantees is made by the Executive Board of Aid Live Foundation.

Aid Live will prioritize,

- Proposals aligned with the founding vision.
- Proposals that already demonstrate impact in the communities.
- Proposals who came from non-profit organizations with long term experience working in communities, with migrants and refugees.

#### **Aid live does not fund,**

- Capital or endowment campaigns, unless aligned with a strategic Foundation focus.
- Projects for the sole purpose of lobbying or funds earmarked for political lobbying.
- Government agencies unless for strategic research or training purposes.
- International agencies unless aligned with an specific project of the foundation.
- Individuals, scholarships, unincorporated associations or groups.

### **Grantmaking FAQ**

#### **What does Aid Live Foundation focus on in its grantmaking?**

The Aid Live Foundation makes grants focused on promoting the integration, comprehensive development and wellbeing of the Venezuelan children in vulnerable communities and Venezuelan refugees in Colombia.

#### **How does the foundation determine what organizations to support?**

We fund organizations working in areas that align with the goals and strategies of our programs and initiatives (Promote the integration, comprehensive development and wellbeing of the Venezuelan children in vulnerable communities and Venezuelan refugees in Colombia). Most of

our grants are awarded to organizations identified by the foundation after a due diligence process.

The foundation could invite letters of inquiry and other types of proposals through open processes. To be informed when those opportunities arise, follow us on Instagram or Twitter. Outside of these opportunities, the foundation generally does not accept unsolicited letters of inquiry.

### **Does the foundation provide scholarships?**

The foundation does not fund individuals, scholarships, unincorporated associations or groups. Moreover, the foundation's funds can be used only for purposes that are consistent with its status as a nonpartisan, charitable organization. For example, we do not fund political candidates or political action committees.

### **Do you make program-related investments Program-Related Investments (PRIs) (PRIs)?**

We focus on creating social benefit through our grants and related philanthropic activities and generally do not make program-related investments — that is, financial instruments, such as loans, guarantees, and equity investments, designed to support charitable purposes that qualify toward a foundation's five percent payout requirement.

### **Can grants be made to a fiscal sponsor?**

Yes, the foundation permits organizations to use fiscal sponsors.

### **Can grantees provide feedback to the foundation?**

Grantees are welcome to provide comments directly to program staff by emailing, about any aspect of our grantmaking process.
